- Early set-up will be allowed. Please advise if you plan on coming in early.
- We plan to have a lot going on - plan to be set up during all open hours. You must get previous permission to open late or close early.
- All vehicles, not part of your display, must be parked outside west gate after set-up.
- Registration fees are:
  - \$40.00 for a 10 Wide x 10 Deep space
  - \$80.00 for a 20 Wide x 10 Deep space
  - Table rental - \$10.00 each (You may bring your own at no charge)
  - We ask that all tables be covered
  - You must provide your own tent
- Set-up time:
  - Wednesday, July 11<sup>th</sup>, 9:00 am-7:00 pm or Thursday, July 12<sup>th</sup>, 7:00 am – 9:00am
  - All vendors must be set up by Thursday, 9:00 a.m.
